OUR COMMITMENT TO SAFETY

Our tax office will be open for the 2020 tax filing season by drop off or by working with us without leaving your home via email and telephone conferences.

DROP OFF AND GO

Gather your tax documents and just drop them off at the front desk or through the front door mail slot, and we'll take it from there. Make sure to put the documents in an envelope with your contact information on it.

WORK WITH US FROM HOME

Email or fax your tax documents to us, and we will complete your return after consulting with you via telephone and/or additional emails.

SCHEDULED DROP OFF WITH A CONSULTATION

Call to schedule a short 10 minute in office consultation and drop your documents off during the consultation. Scheduled consultations will be limited and returns will not be prepared during that time. You will need to call when you arrive so that we can ensure no one else is in the conference room at that time. Masks will be required. These are subject to change if the State mandates an office shutdown.

TAX RETURN PICK UP PROCEDURE

Once your return has been completed, a staff member will contact you via email/telephone to let you know that your return is ready.

PICK UP IN OFFICE

Please call the office when you arrive so that we can ensure no one else is in the conference room at that time. Masks will be required. If you would prefer not to come inside the office, everything can be placed in our milk box right outside our door with a pen and you may pick up and sign through there. All forms will need to be signed and payment for services received before the tax return can be e-filed.

PDF TAX RETURN OPTION

Please let your return preparer know that you would like your tax return copies sent to you via PDF before the return is completed. Once the return is completed, the signature and our payment forms will be emailed to you, to be signed and sent back to us via email or fax. Once we receive the signed forms and our payment for services, we will send your tax return copies to you via email and e-file your return. Your source documents, if originals, will be mailed back to you.
